HOUSE RULES & MEETING GUIDELINES (5 minutes)

- KBOO House Rules & Meeting Guidelines
 - Technical difficulties prevented a reading of the house rules and meeting guidelines
 - The board discussed their importance and we will resume reading them in August

APPROVE AGENDA (5 minutes)

- Approve July 2024 Board Meeting Agenda
 - Motion to approve Jill

 - Motion is approved

PUBLIC PARTICIPATION (10-15 minutes)

- Jo visited the board meeting to speak about concerns but first asked if there were any
 people in attendance of the meeting who were not board members.
 - Emma explained that there were indeed people other than directors in attendance.
- Jo introduced themselves without pronoun preferences and without a last name but stated they were a KBOO member.
- Jo requested the following before the end of the meeting:
 - Bylaws
 - changes going as far back as KBOO has records
 - proposed bylaw revisions going back as far as KBOO has records
 - Who proposed the changes
 - How did individual board members vote
 - Board meetings
 - How individual board members voted on proposals for the past several years
 - Board meeting minutes for the past several years
 - Board meeting transcripts
 - Board meeting recordings
 - Jo said, s a member, they have a right to this information
 - And went further to say "failing to provide access to those records is a violation of KBOO bylaws, as I understand them"
 - Jo wanted to know who would be responsible for obtaining all of this information.
 - Emma explained that Jo would not receive this information before the end of the meeting., partly because the board was in the middle of a scheduled meeting.
 - Jo was told that most of the information they were seeking can be found on kboo.fm.
 - KBOO is required by the FCC to provide meeting minutes to the public
 - KBOO does not provide transcripts and recordings

- Emma also explained that there was 1 proposed bylaw change this year but it was voted down by the board so the proposal will not go to the membership for a vote.
- Zale agreed to provide information on bylaw changes and proposed updates.
- Jo wanted Emma to provide a deadline for gathering this information
 - Emma declined to provide a deadline as she did not know how long it would take to obtain this information.
 - Jo insisted that there be a deadline and proposed 3 weeks
 - Emma agreed to 3 weeks
- Jill asked why Jo was seeking all of this information
 - Jo responded that they have anxiety and concerns about transparency at KBOO
- Jo noted that the meeting ID's/zoom links for board committee meetings have changed over the past 9 months and asked if this was intentional.
 - Emma explained that the board was trying to get all board and committee meetings onto 1 account rather than several people's personal accounts
- Jo mentioned that they had contacted the Web Coordinator to offer help with the maintenance of the current website/construction of the new website but did not hear back
 - Emma explained that staff have a different responsibility to volunteers than the Board of Directors does.
 - Staff will/can respond depending on their workload. If they don't get to volunteer correspondence before their hours are filled for the week, it is not meant to be disrespectful.
 - Directors do have an obligation to respond to members' requests.
- Jo apologized for their tone and explained they were disgruntled after seeing what happened to other cooperatively governed structures in the POrtland area including Food Front grocery co-op and City Bikes workers co-op. Jo said they were very nervous.
- Jo said they heard KBOO passed a deficit budget for 2 cycles and said that that was concerning to them.
- Jo asked if there were records of how Directors voted on these budgets
 - Emma explained that there are records of the budget votes in the Board Meeting Minutes and that the budget vote usually occurs in September or October
- Jo suggested to the board that all meetings be recorded and the transcripts be made available to members and that members vote on the budget.

- Jo went on to state that the FCC requires KBOO to provide records of the meetings and that the level of transparency at KBOO was not what they hoped for.
- Emma told Jo that she needed to stop Jo there because the Public Participation speaking time was up as 15 minutes had passed.
- Emma thanked Jo and said the members voting on the budget is a good idea and suggested they take it to the Governance and Policy Committee.
 - If Governance and Policy recommends the proposal to the board, the board will vote
 - If the vote passes the proposal it will then go to the membership during the Annual Meeting or they could convene a special meeting of the members.
 - 5% of the membership is required for quorum.
